

Operational Guidelines

During the current situation with the COVID-19 outbreak, the Logan Lake Campground is open and has put in place measures to ensure everyone's safety while visiting the campground. We ask that all users adhere to the safety measures indicated as we move into our 2020 camping season.

The Logan Lake Campground will be offering camping with limited services at this time. There will be no access to the campground washroom or shower facilities during this time. If you are visiting us, you must be in a self-contained unit; there will be no access for tents or units that are not self-contained at this time. There will be electrical, TV and internet services available. There is water available through the five taps located at the campground or you can arrive with your water already on board. All regular campground rules are still in place with modifications listed below.

Social Distancing Procedure

As a general safety procedure while visiting the campground, please observe social distancing rules as per recommendations from the Province of British Columbia, between yourself and others. It is recommended that all people of differing households maintain a minimum distancing of 2 meters between themselves and others.

Virtual Check-in Procedure

The campground office allows only one visitor inside at one time. You can also contact us through the campground office phone (250-523-6283).

- Check-in time is after 3pm. This allows the campground staff enough time to follow our cleaning procedures while still being able to maintain social distancing guidelines between guests.
- Upon arrival, please either call the campground office or check in person to the office, to confirm to us your arrival and complete the check in procedure.

Virtual Check-out Procedure

- Check out time is 11am. Please ensure that you have vacated the campsite at this time so that our staff is able to get access to the site and prepare it for the next visitor.
- After you have vacated the site please contact the office phone number or in person to confirm your check out and so that we are able to check you out on our system as well.

Fire wood

- Fire wood is available and is \$8 per bundle. To limit the contact between persons we ask that you have exact change, and we can accept payment through credit card. Payment arrangements can be made by phoning the campground office.
- Fire wood will be delivered to the end of your campsite driveway between 4-6pm. Firewood orders must be placed before 3:30pm each day through the campground office number listed.

Loan out Equipment

- The campground will not be loaning out equipment to campers at this time.

Trails and Walking Paths

- These are open for use; please respect the social distancing procedures while enjoying the outdoors.

Water and Sani Dump

- The Logan Lake campground has 5 water sources located throughout the campground which will be available for use. Individual sites do not have water hook ups. The Sani Station in Logan Lake will be open for waste water disposal. There is also a water tap located at this location, but from a sanitization viewpoint, as this is an unmanned station we cannot guarantee what the water hook up has been used for from the previous user.

Sani Dump Location and information

- Driving Directions: off of Hwy. 97C between Merritt and Ashcroft in front of the municipal works yard going into town (please follow available signage).
- Dump Station User Fee: Donation requested; proceeds support the Logan Lake Lions Club.

Public Places

- **Gazebos, Docks and Boat Launch:** All are open but please follow the current social distancing guidelines as recommended by the Province of British Columbia.

Please be courteous with the length of time that you use the public spaces. So that other visitors also have the chance to enjoy using the Gazebo, Dock and Boat Launch.

Groceries and Supplies

- Please plan to come prepared with everything that you are going to need during your stay. There are phone in orders and deliveries or pick-up available from some of the establishments in Logan Lake. We will have some information from the available vendors at the Campground office

 - If you have any symptoms or are sick please do not enter the store.
 - Social distancing procedures must be followed.
 - There is a limit of 10 people in the store at a time (1 person per household at a time please).
